ON this and following pages appear the photographs and biographical sketches of the current officers and directors of Lions International. All Lions are grateful to these men who are true servants of humanity, devoting their wisdom, energy and resources to the ultimate benefit of all mankind.

What are they like, these men? Some few of you are fortunate enough to have one of them as a member of your own club. Others will perhaps have the opportunity to meet at least one of them sometime during this year. Most, however, will not be so fortunate. It is for you, then, this latter group, that we have quizzed these leaders of ours and obtained rather personal information which should tell us what they are really like.

First of all, it is evident from their answers, that in most respects they are pretty much like you and me. They have an average height of five feet nine and one-half inches, and they tip the scales at a-not-too-portly 187. Among them there are twice as many with brown eyes as with blue, and the majority have (or have had) brown hair, now graying. They have an average of 21/2 children, and 1 3/5 grandchildren with prospects for an increase in this latter department since the average age of the group is only 52. Two-thirds of them have had college training, which may account for the relatively old age at time of marriage-25 years. Ten of the group are Roman Catholic. Of the 23

who adhere to other faiths, the Baptists and Methodists claim the most, with five each. They have been Lions for 20 years. Employmentwise, they are a heterogeneous bunch including manufacturers, merchants, professional men, farmers, government workers and (we're not kidding!) a goldfish distributor. Twenty-one of them own their own businesses. Among the professional group, there are three lawyers, one engineer, a medical doctor and a doctor of chiropractic.

How about their living habits? Mr. Average Director resides in a seven-room house and gets up each morning at 6:45. He eats a light breakfast and likes his heaviest meal in the evening. Steak is his favorite food, 3 to 1. In the dessert department, ice cream takes the cake. One-third of the group are non-smokers, and among the rest, cigarettes are twice as popular as either pipes or cigars. Most prefer clothing of blue or brown, and bow ties are scorned by more than half. Only one-third of the group plays golf (average score: 100), but most believe in taking frequent and adequate vacations.

Perhaps the key to the reason for their devoted service to Lionism lies in their answers to our question: "What is your personal philosophy of life?" Here is a typical answer: "To live a useful and productive life. To bring honor to my family and friends. To be able and willing to help the weak and needy and thus strengthen my community and fellowman."



JOHN L. "JACK" STICKLEY, Charlotte, N.C. International President-1956-57. The mild-mannered, deepthinking Southern gentleman who heads your Association this year was born in Cambridge, Mass., but has lived most
