


OFFICERS & DIRECTORS OF LIONS INTERNATIONAL

Jorge Bird, San Juan, Puerto Rico, is the President of Lions International. Lion Bird, a past International Director, is a Key Member of the Rio Piedras club. He was named Ambassador of Good Will prior to his election as Third Vice President in 1964. In 1965, he earned Extension Awards for founding clubs in the Dominican Republic, Spain and Jamaica, and two years later was presented with the Puerto Rico Lions' highest honor—the Eugenio Maria de Hostos Award—for having done the most for the Commonwealth. He was born in Guayama, Puerto Rico, studied commerce at the University of Puerto Rico, and now presides over Bird Enterprises, which includes food, travel, gasoline, dairy and real estate interests. President Bird is a member of the Board of Vocational Education and the President's Council of the Inter-American University. He also has served as a director of the Inter-American Chamber of Commerce. A past president of the Puerto Rico Chamber of Commerce, he founded the local convention bureau. He and his wife, Victoria Luisa Vilella, have five children and three grandchildren. He is a Catholic.
