


Officers and Directors Lions Clubs International 1981-1982



Kaoru "Kay" Murakami, of Japan, is the President of Lions Clubs International. He served as an International Director during 1975-77 and was elected International Third Vice President at the 1978 Convention in Tokyo, Japan. He was also chairman of the third Asian Lions Forum in 1964 and vice chairman of the host committee for the 1969 International Convention in Tokyo. President Murakami has received nine International President's Awards, three Extension Awards, the Ambassador of Good Will Award and is a Key Member. 




Farice Bruce, Jr.
